Regeneration Update:

We would like to assure residents that Waltham Forest Council is fully committed to the regeneration of the Avenue Road Estate, following Bellway Homes withdrawal from the scheme. We are now assessing alternative routes to deliver the regeneration scheme.



We will continue to ensure that residents are kept informed as the Council look to develop alternative proposals.

We have set up an online meeting on **Thursday 16th November 2023, 6pm** to address questions from residents and provide some more information about the next steps (see details below).

Why did Bellway withdraw from the scheme?

Bellway Homes announced it will be closing its London Partnership Division and reducing its workforce.

This is due to the challenging market conditions which have seen build costs rise significantly, rises in the interest rates, and a decrease in sales of homes. The Council received notification from Bellway withdrawing from the scheme because of these factors.

Frequently Asked Questions (FAQs)

This FAQ section aims to address the most common questions and concerns that have been raised by residents about the next steps in the regeneration process.



Your Question:	Council Response
What are the next steps in the process from the council?	The Council is committed to redeveloping the Avenue Road estate and currently looking all its options to deliver the scheme. The Council is unable at this time to confirm what that could look like. As we will need a few months to pull this together and share with residents prior to going to Cabinet early 2024.
	The Cabinet system is a model of governance that is used by most councils including Waltham Forest Council. The Cabinet members are made up of local councillors, the leader and deputy leader of the council who all have specific areas of responsibility. The Cabinet meets regularly and is a decision making body to enable the council to progress with their strategic objectives about key matters in the borough.
Will the masterplan, design proposals, and phasing plan/order of blocks to be rehoused remain the same?	Until we have looked at all options to deliver the new homes we are unable to confirm at this stage if there will be any changes to the current phasing programme or to the current consented plans for the Avenue Road Estate.
How will this affect those that are in need of rehousing, including those in urgent need, those in overcrowded accommodation, or those who have medical conditions?	Unfortunately, Bellway having to walk away from carrying out the development has meant that there will be a delay to delivering new homes. The Council is working to pull together a proposal that will still deliver the much-needed homes. In the meantime for residents who are overcrowded, or have urgent need to be rehoused, your Tenancy Officer is best placed to support residents with this matter. What will happen to the outstanding repairs and maintenance on the estate, and our homes?	The council is committed to maintaining the estate and your homes. All repairs should be logged through the Council repair channels, by calling 020 8496 4197 or emailing w)repairs@morgansindall.com. Any outstanding repairs should also be raised with your Tenancy Officer who is best placed to escalate your repairs.
Will we still have an Independent Tenants' & Residents' Advisor? (ITRA)	Yes, NewmanFrancis who are the ITRA for the Avenue Road Estate will continue to support the residents through the regeneration journey.
Will we still have weekly presence from project staff (e.g. project shop sessions / ITRA coffee & chat)	One of the biggest successes for this project has been the engagement between the residents, NewmanFrancis and the Council. The Council is committed to maintaining and developing these relationships. The Coffee afternoons and Project Shops will continue.
Will this affect our compensation entitlement to receive the Home Loss Payment and Disturbance Allowance?	All residents will still be entitled to compensations once their new home has been created. This also includes those who choose to move outside of the estate in line with the regeneration process when priority decant status is awarded.
Will the council secure the area where Bellway had 'broken ground'?	The Council intends to look at ways to makes this area secure.

Update from Decant Officer:



Michelle Carroll is the dedicated Decant Officer who has been appointed by the council to work with Avenue Road Estate residents throughout the regeneration.

Over the past few months, Michelle has contacted the majority of households on the estate to discuss their housing needs and preferences.

If you have not yet discussed your housing needs, please contact Michelle (details below).
