Planning Approval Update:

Bellway Homes submitted the planning application for the Avenue Road Estate regeneration scheme last year in October 2022.

The latest update on the planning status is that the council have now successfully achieved full planning approval.

The Greater London Authority (GLA) who are governed by the Mayor of London provided full approval for the scheme in March 2023.

Following the planning approval, Bellway Homes who are the developer, commenced a soft start on site last month as part of a 'breaking ground' ceremony (pictured below).

This enabled the council to draw down on grant funding from the GLA to progress the regeneration scheme.

Next Steps:



Following approval for the scheme, Waltham Forest Council & Bellway Homes are currently working behind the scenes to develop the phasing plan in more detail, and are preparing for an indicative start on site for the building works of the first phase to begin later this year in Winter 2023.

The anticipated physical works later this year will include hoarding off the site (by the portacabins on Hall Road) and laying down the foundations for the building of the first new block.

Ahead of these works, Bellway Homes will be working with residents over the coming months around detailed designs.

Update from Decant & Allocation Officer:



Michelle Carroll is the dedicated Decant & Allocation officer who has been appointed by the council to work with Avenue Road Estate residents throughout the regeneration.

Please also contact Michelle, if you or a member of your household is a wheelchair user, has a disability, or will require special adaptations.


If you have any additional support needs that you would like to discuss further with the team, please get in touch with Michelle.
