

Church Hill E17 Permit Parking Consultation

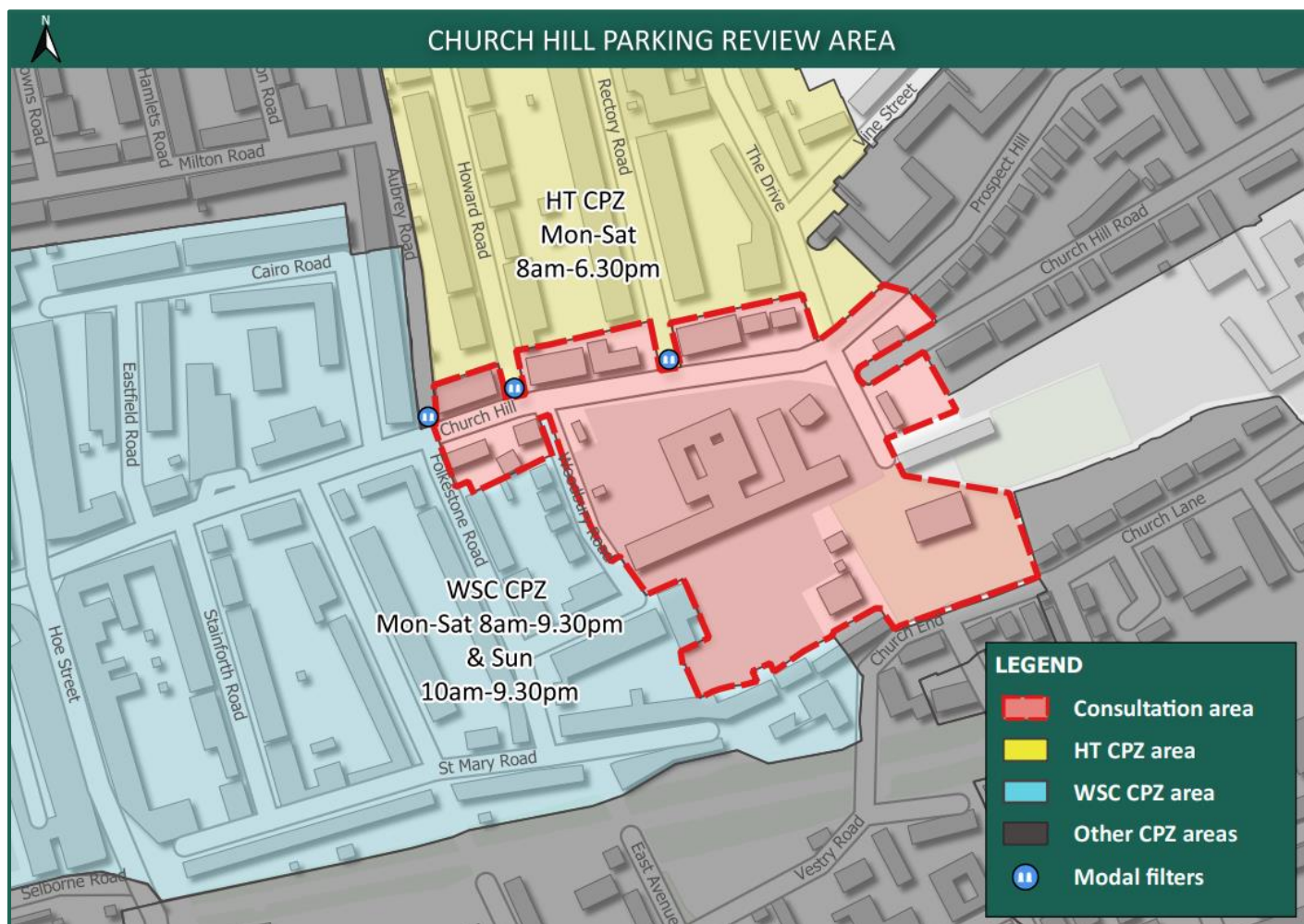
We're proposing changes to parking on your road

Dear Resident, Business or Occupier,

In July 2020, modal filters were introduced in Howard Road and Rectory Road following a consultation with local households, as part of the Hilltop area improvements. We now would like your feedback on how permit parking is working for you. To ensure parking is more accessible for residents and businesses impacted by these changes, we are proposing to change the current Controlled Parking Zone (CPZ) boundaries to incorporate some properties along Church Hill into the Walthamstow Central (WSC) CPZ.

The WSC CPZ operates from Monday to Saturday, 8am to 9:30pm and Sunday 10am to 9.30pm. If the majority of respondents to this consultation are in favour of changing to the WSC CPZ, the times of operation for your road will change to these hours. You will then be able to park within any road within the WSC CPZ area and you will no longer have access to permits for the Hill Top (HT) CPZ.

A map of the area under review is shown below.



Local people know their neighbourhood best and we're asking everyone living or working in this area to tell us what you think about these changes. The decision on whether the CPZ boundary will be changed will be made wholly based on the results of this consultation.

To express your views, please complete the attached questionnaire at the end of this document and return it in the prepaid envelope provided to reach us before **31 July 2024**. This is the same envelope in which you received these documents. Alternatively, you can send a digital copy of the completed questionnaire to cpz.schemes@walthamforest.gov.uk. Due to the high volume of responses, we will not be able to provide an individual response to each survey, but will notify you if any changes are made.
