TRAFFIC CALMING - EXTENSION OF SPEED CUSHIONS ON BUS ROUTE. SOUTH COUNTESS ROAD E17 AND PRIORY COURT E17

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest, in accordance with Sections 90A and 90C of the Highways Act 1980, the Highways (Road Humps) Regulations 1999, as amended, proposes to
 - a. extend the length of the sinusoidal humps (known as "speed humps") proposed in September 2023 from 4 metres to 8 metres (which also converted speed cushions to speed humps) in:
 - i. South Countess Road (1) outside Nos. 189/191, (2) between the 2 arms of William Morris Close, and (3) outside Nos. 227/229; and
 - ii. **Priory Court** (1) immediately south of Nos. 154 to 164, and (2) immediately north of Sherwood Close.
 - b. convert the speed cushion (concrete, asphalt, plastic, or rubber) to speed hump (up to 8 metres in length including the gradients) in: **Priory Court** between Xavier House and No. 154.

NB/ The sinusoidal road humps, also known as 'speed humps', would be elevated sections of carriageway, between 75 and 100 millimetres higher at their highest point than the surrounding carriageway, extending across the full width of the carriageway (less space for drainage) and up to 8 metres in length. The proposed location for each speed hump is extended in case of any site constraints.
