CHANGE FROM ADVISORY TO DESIGNATED DISABLED PERSONS PARKING PLACES, AMENDMENT OF ADJACENT PARKING PLACES AND WAITING RESTRICTIONS AND REMOVAL OF DISABLED PARKING PLACES (BATCH 17) (T55(24))

The Waltham Forest (Charged-For Parking Places) (Amendment No. 230) Order 2024 The Waltham Forest (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 226) Order 2024

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Waltham Forest on **21st November 2024** made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The general effect of the Orders will be:

- (a) to provide a designated disabled persons parking place (dppp) measuring 6.6 metres in length (unless otherwise specified in the Schedule to this Notice) in each of the locations specified in Schedule 1 to this Notice, in most cases replacing advisory dppp, on the carriageway, footway or both;
- (b) where any proposed designated disabled persons parking place referred to in sub-paragraph (a) above is longer than the advisory dppp it is replacing or where there is no existing advisory dppp in the proposed location, to shorten or remove any existing parking place or waiting restriction in that location by the length necessary to provide the dppp; and
- (c) to remove either advisory or formalised dppp in each of the locations specified in Schedule 2 to this Notice and either extend existing or create new permit parking space; or in certain cases extend adjacent waiting restrictions bordering such disabled parking space by the length necessary in place of the dppp.

3. **FURTHER NOTICE IS HEREBY GIVEN** that the Council under the same RTRA sections mentioned in item 1 made minor amendments/corrections to:

- (a) traffic order map schedules for **Arundel Close E15** – east to west arm – to govern permit parking areas for CH permit holders only operating Mon-Sat 8am – 6.30pm which has been in operation since 2010;
- (b) road markings in **Radbourne Crescent E17** – outside Nos. 13 to 29 to extend the existing disabled bay such that its overall length is 6.6m rather than 6.4m.

Note - The proposals advertised on 12th September 2024 for disabled bays in: **Bridge End** – outside No. 27 and No. 40 have been abandoned; and outside No. 32 (4.3m), No. 34, and No. 48 (5.1m) have been deferred and at a future time will be either made as proposed, amended or abandoned.

4. Copies of the Orders, which will come into operation from **25th November 2024** and all other relevant documents can be inspected until the expiration of a period of 6 weeks from that date on request by either emailing traffic.scheme@walthamforest.gov.uk or visiting (*by appointment) the Highways and Traffic Management office, Low Hall, Argall Avenue E10 7AS during normal office hours on Mondays to Fridays inclusive; or alternatively documents can be viewed online at: www.walthamforest.gov.uk/content/road-traffic-schemes-and-consultations.

5. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Orders may, within six weeks of the making of the Orders, make application for the purpose to the High Court.
