The Council of the London Borough of Waltham Forest, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984¹, and of all other powers thereunto enabling, hereby make the following Order: -

1. Citation and commencement

This Order may be cited as The Waltham Forest (Prescribed Routes) (Pedestrian and Cycle Zones) (Amendment No. 22) Traffic Order 2024, shall come into force on 12th December 2024.
