## Brand-new fitness centre and nursery opens in Leyton

Leyton residents have welcomed the new and improved Score Centre and adjacent Nappy Gang Nursery in Coronation Square.

Both have been reimagined and made bigger and better than they were at their previous sites, just around the corner.

A grand opening event on Thursday 28 November featured a ribbon-cutting ceremony with a special appearance from Saracens Women rugby club legend, Sonia Green, who praised the new Score Centre for its facilities that promote health and wellbeing in the community.

Waltham Forest residents were invited to the fitness centre, covering over 50,000 square feet, to enjoy free badminton and pickleball taster sessions and even the popular strengthening exercise class, Pilates, giving locals the opportunity to try something new.

A showcase netball tournament took place on Court 4, watched by spectators from the new bleachers.

Guests also visited the new Nappy Gang Nursery, where local children will play, learn, and make new friends.

## Investing in local people and essential services

### Managing council taxpayers' money sensibly

**Residents have been given an update on how the council is investing taxpayers' money carefully and responsibly in the face of the serious financial challenges facing local authorities across the country, including Waltham Forest.**

The Medium Term Financial Strategy (MTFS) was presented to the Cabinet at a meeting on Tuesday 5 November. The report sets out the anticipated funding gap and savings required for the council over the next three years.

It forecasts an in-year overspend of approximately £17m, and a difference of £18m to £24m between what the council will spend over the next three years and its estimated income. Social care for adults and children and supporting children with special educational needs account for most of these costs.

Cllr Grace Williams, Leader of the Council, said: “We are doing all that we can to safeguard the essential services on which you and your family rely, and at the same time protect our borough’s finances.

“As you will be aware, councils across the UK are facing huge financial challenges. The majority of our money goes into caring for older and disabled people, and supporting children in care or those with special educational needs or disabilities. We will do everything in our power to meet our most important responsibilities, but this means we face some tough decisions.”

## Costs and demand for council services continue to rise

### Adult social care

Alongside the significant increase in demand for social care, the needs of those receiving care are becoming more complex.

The council is caring for 850 more adults than it was five years ago, an increase of nearly a third. Over the financial year 2023/24, the average cost of adult social care packages has risen by 10 per cent.



### Special educational needs and disabilities

The picture is similar when looking at services for children with special educational needs.

The number of children that need Education, Health and Care Plans (EHCPs) has risen from 1,880 in 2018/19 to 3,471, an increase of 85 per cent. The figure has gone up by 14 per cent in the past year alone.



### Temporary accommodation

The costs of helping people who need housing support from the council are rapidly rising, while the availability of suitable temporary and permanent accommodation is declining.

In Waltham Forest, there are currently 1,400 households housed in temporary accommodation with approximately 100 in commercial hotels.

## Christmas and New Year opening hours

### Contacting the council

Except for emergencies, the customer call centre on 020 8496 3000 will be closed on the following days:

- **Christmas Day, Weds 25 Dec**
- **Boxing Day, Thurs 26 Dec**
- **New Year's Day, Weds 1 Jan 2025**

During the rest of the holiday the call centre will be operating normal times, between 9am and 5pm.

### Town Hall reception

Waltham Forest Town Hall will be closed Christmas Day, Boxing Day, and New Year's Day. It will be open for the usual hours on all other days, between 9am and 5pm.

### Libraries

The opening hours of our nine libraries will change for the Christmas holidays before returning to normal from Fri 3 Jan 2025. Please note all our libraries will be closed on Christmas Day, Boxing Day, and New Year's Day.

### Family Hubs

The Chingford, Walthamstow, and Leytonstone Family Hubs are all closed from Weds 25 Dec until Thurs 2 January.

The Queens Road Family Hub is closed Christmas Day and Boxing Day. It will be open as usual between Fri 27 and Tues 31 Dec, closed on New Year's Day, and open as normal from Thurs 2 Jan.

The Family Hubs helpline, 020 8496 4965, will be open every day between 9am and 5pm except for Christmas Day, Boxing Day, and New Year's Day.

### Community Living Rooms

Most Community Living Rooms will be closed from Fri 20 Dec until Fri 3 Jan 2025. For the most up to date information, please contact the spaces directly using the QR code to access details.



### William Morris Gallery

The William Morris Gallery will be closed on Christmas Day, Boxing Day, and New Year's Day. It will close early at 4pm on Christmas Eve and New Year's Eve.

### Walthamstow Wetlands

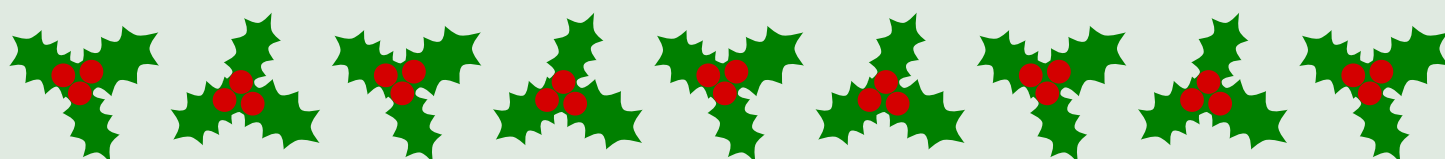

# A warm welcome guaranteed

Drop in to one of our Community Living Rooms this winter

**This winter, our network of Community Living Rooms are open again, and welcoming people in across Waltham Forest. From Chingford to Leyton, we have 19 spaces where anyone can drop in.**

Each one is different but many of them will offer a warm space to relax, socialise, take part in activities, use the internet or have some refreshments.

The Lighthouse Project at St. Mary's Church, Leyton, is a Community Living Room offering a hot meal, tea and coffee, good quality shoes and clothing, and period products.

Back in 2020, they initially set up a pop-up food bank in response to the pandemic, distributing meals to those who needed them.

After a year, they started to wonder what more hospitality they would be able to offer residents, and the project has evolved into

the Community Living Room you can drop in to now.

As well as sharing food and clothing, Lighthouse host other agencies in their space, including representatives from the NHS and the council, to help anyone who needs extra support.

This winter, they'll be distributing hampers to their guests and others in the community, working alongside other local organisations.

The volunteers who help at Lighthouse each week are keen to make the space feel like it belongs to their guests as much as the church, with different areas to socialise in, cosy sofas, and a relaxed atmosphere.

“We thought about the small touches we can

add to make it feel like someone's living room, like someone's home – a space to be with friends,” says Hannah Seekings, who runs Lighthouse.

“We're passionate about people belonging, so you're welcome to come in, and you're welcome to bring others in with you. We want everyone to feel like they're part of a community and that they belong in this space. Our vision is for this to be a real community hub and a beacon for hope.”

## Stories of Sanctuary: MK's journey

Supporting asylum seekers in Waltham Forest

**In Waltham Forest we value and celebrate the migrants, refugees and people seeking sanctuary who have settled in Waltham Forest. In December 2023 we were officially recognised as a Borough of Sanctuary through the national charity City of Sanctuary.**

MK\* shares his own story of arriving in Waltham Forest. He met the council's Single Point of Contact (SPOC) Advice Service for Migrants team soon after he arrived in Waltham Forest, who supported him with accessing college courses and volunteering.

**"I have been in Waltham Forest since July 2022. I was driven from the airport to a hotel in Waltham Forest, where I lived with refugees from many different backgrounds who were all seeking asylum like me.**

"I felt a lot of solidarity in the hotels with fellow residents and this helped me cope with the daily frustration and fear that was building up inside me. I had traditional clothes from my country that I wear for meetings and the dried fruits of peace that my late grandmother gave me. She used to tell me that "whatever the difficulties in life, chew them and the sweet taste of this fruit should be the same as the taste in your daily life".

"At Waltham Forest College I'm doing ESOL Level 1. The college has rules and policies which I can follow. Here I feel like I never have problems. It is good to feel supported there.

"I used to get confidence from playing football back home. Because of the injury I have on my foot I can't play. Football gives me peace of mind and people can use football to release stress. I was supported by a council worker to a project that supports refugees with learning English through football. I am now able to use my knowledge and skills in football - and my experience in learning English - to design sessions that will support refugees who are on a similar journey to me when I first arrived.

"With all aspects of the support I have received from Waltham Forest, I would say this place is doing well. When I tried to say something difficult, people would not be upset and tell me I wasn't allowed to say that, they would help me to understand a better way to communicate with respect. It helped me."

# Waste not want not

Residents recycle increasing amounts of food waste thanks to new collection scheme

**Almost 900 tonnes of food waste has been recycled in Waltham Forest since the launch of the new scheme – the equivalent weight of over 150 elephants!**

Separate food waste recycling collections have been introduced for all kerbside properties in Waltham Forest on a weekly basis, a process completed by mid-October.

This is alongside the rollout to communal properties, set to be completed by March 2025.

Statistics from the North London Waste Authority show that roughly 30 per cent of what is found in black bins is food waste and could easily be converted into biofuel instead.

Leytonstone resident Paul Bishton is one of our Binfluencers, who helps to

spread messages in local networks about how to recycle right.

He said, “I’ve been talking to my neighbours and helping them to understand what to do with their food waste. I always try to plan ahead and minimise food waste, but sometimes things go off and unavoidable items like apple cores and banana peels can be recycled. It’s so important that we recycle as much as we can to do our bit for the environment.”

Cllr Clyde Loakes MBE, Deputy Leader and Cabinet Member for Climate, said, “I’m pleased that our

residents are diverting their food waste successfully, from their black bins into their new food waste caddies. It shows that Waltham Forest residents are doing their bit for the climate – thank you for responding so well to this new weekly service.

“As we enter the festive period, I’d encourage everyone to be resourceful and try to eat leftovers. Inevitably there will be some food waste, such as peelings, bones and yes, some sprouts; these now belong in your food waste caddy.”

### CHINGFORD

**Chingford Green:** A fixed CCTV camera has been installed on Station Road, to be in place for five years.

**Endlebury:** The toilets in Ridgeway Park have been refurbished.

**Larkswood:** Our tree planting programme has kicked off in Larkswood and will be continuing across the borough.

### WALTHAMSTOW

**Upper Walthamstow:** New bins have been installed at either end of Buck Walk.

**Upper Walthamstow:** New calisthenic gym equipment has been installed in Bisterne Avenue Park.

**Forest:** Gym equipment has been fixed and repainted in Abbots Park.

**Hoe Street:** Improvements have been made at Vestry Park, including replacing the old seesaw and repainting the lines on the basketball court.

**Hoe Street:** Funding has been given to the St Mary's Churchyard Gardeners to continue their outstanding work around the church grounds and graveyard.

**Leytonstone:** Improvements have been made to Dyers Hall/ Grove Green Road older children's playground.

**Leytonstone:** An old brick planter has been replaced with a new pocket park at Fillebrook Road/Grove Green Road.

**Cathall:** The gym equipment in Cathall Green Park has been improved, with a new exercise bike and monkey bars installed.

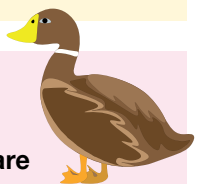
There will be matinee and evening performances of both shows throughout the festival, alongside opportunities for community groups to use the space as a platform for their own work.

## Vestry House Museum update

### New operator to be appointed soon

**A major milestone was reached when the revitalisation of Vestry House Museum received planning permission and listed building consent in July.**

The scheme includes a sensitive refurbishment of the 18th century core of the building, conversion of previously back-of-house rooms into creative workspace, increasing the physical accessibility and environmental sustainability, and transforming the garden building into a new café and event space.

Architects Studio Weave are now working closely with the council’s culture team on the redisplay and reinterpretation of the museum collections, which will be developed with community partners over the coming year. This will include many objects not previously on public display.

We’ll be appointing a new operator to manage the site including the workspaces and café and working with them to plan programmes and activities for residents - including training and paid opportunities for local young people.

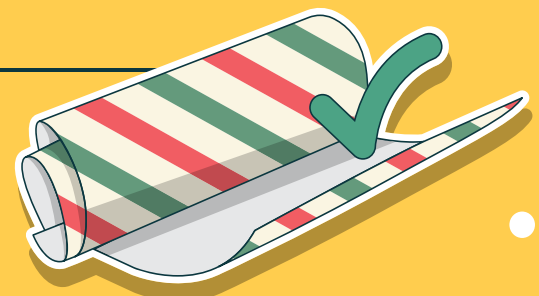

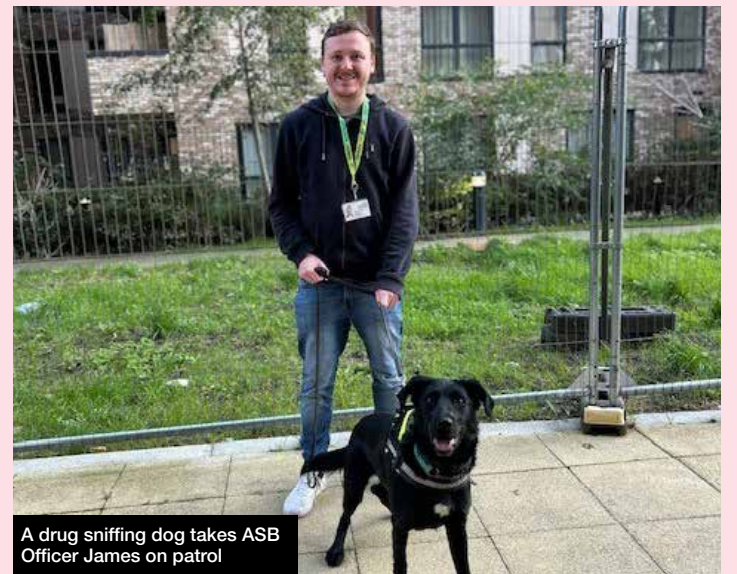

# Over-50s: join the bowel movement today

Simple bowel cancer screening kits available for thousands more residents



Local resident Phil explained why testing for bowel cancer is so important

**From September 2024 the NHS extended its free bowel cancer screening programme to 50-year-olds. Every other birthday from 50 to 74, residents who are registered with a GP will get a self-test kit in the post.**

Local resident Phil recently spoke about why it's so important to join the bowel movement and use the kit every time it's sent in the post.

"Early detection is always very important with any cancers," he told us. 16 years ago, he went to his GP, not feeling quite right. Some tests were run and cancer was detected. Fortunately, it was caught at an early stage, which allowed for successful treatment.

Bowel cancer is the third most common type of cancer and is one of the cancers that can be caught early. Screening is very simple and can be done without going to a GP or hospital.

"It only takes 10 minutes, if that," Phil said. "You do it in the comfort of your own home at a time that suits you. There is no reason not to do it and knowing your results puts your mind at rest. It's always a relief to see there's no cancer."

# From addiction to recovery

## Supporting rough sleepers through drug and alcohol addiction

**We spoke to Corey, Team Leader of the Rough Sleeper Drug and Alcohol Team at Change, Grow, Live Waltham Forest, the council's drug and alcohol service.**

“My team’s priority is to make drug and alcohol treatment readily available to the rough sleeper population of Waltham Forest. These members of our community often have complex needs. They can find there are barriers to accessing public services, like ours: our job is to remove these barriers.

“When we work with people in the rough sleeper community, we work with them as a whole person, recognising they might have a lot of complex needs and that someone’s trauma

can have a negative impact on them. We meet people where they’re at – much of our time is spent on the street, doing what we call assertive outreach.

“We know the borough and the rough sleeper community really well, and they’ve come to know us too. We support this community in getting their needs assessed, which helps give access to important things like life-saving health

interventions, blood-borne virus testing and treatment, harm minimisation services, psychosocial treatment, and referrals to other public services, including teams that help with housing.

“Our philosophy is to make all of that always available at street level, week in, week out, throughout the year, rain or shine.

“I love what I do – my whole team does. We’ve seen people make the transition from addiction on the street to recovery and a life transformed. We’re always there for those struggling with drug and alcohol use on the streets of Waltham Forest.”

# Why I work in social care

## Waltham Forest social worker Mariam tells us about her journey into children’s social work



“My passion is to make a difference. I want children to have a really positive childhood with proper support” says Waltham Forest social worker Mariam

**“Put the child at the centre: that’s my ethos. If a parent doesn’t want to speak to you, for example, you have to work through that, because this job is about supporting the child.**

“I’m always friendly and non-judgemental – I never have preconceptions about the situation I’m going to walk into because every family is different. I’m also very honest. If you’re transparent from the start, families and children know where they stand with you.

“My passion is to make a difference. I want children to have a really positive childhood with proper support, because that gives them better prospects – a safe, loving home will improve their mental health, keep them at school and give better lifelong prospects.

“I didn’t get into social work straight away. I started doing childhood studies and did a placement in a residential home for looked-after children. I saw the positive impact these children’s social workers were having and I thought: that’s what I want to do.

“After my Master’s in Social Work I looked around a few local authorities, including Waltham Forest. The interview was different here. Other places were focused on your Maths and English skills. Waltham Forest asked about scenarios and how I’d handle them – they wanted to know what I’d bring to the job.

“I got a lot of support as I started, with lighter caseloads and loads of shadowing and training opportunities. As I got more experienced, my managers pushed me to keep progressing – they saw my skills and wanted me to develop.”

## Fryer learning

How do you combine cooking meals cheaply with healthy eating and doing your bit for the environment – plus a fun social occasion? A new air fryer course teaches residents how to use the popular energy-saving cooking equipment in a group setting, encouraging socialising while you learn.

A partnership between the

council's Adult Learning Service and Early Help teams, the five-week 'Basics of Air Frying' course welcomes older people and people living with a disability.

Sessions extend beyond air frying, covering how to make delicious and healthy food, energy-saving household tips, and support with budgeting. Learners enjoy the fruits of their labour after each session with a communal lunch.

"I live with my disabled daughter, who I take care of full-time," said one learner. "Learning how to use an air

fryer has shown me that I can prepare meals cheaper, because it takes less time to cook.

"This will help me save money on my energy bills, because it takes half the time it would in the oven, and I can make more things in one go!"

The coordinator of the unique project, supported by the Household Support Fund, said: "Anxiety around energy costs was stopping people turning their ovens on to cook a balanced hot meal – we also know that older people in the borough can feel isolated and lonely. Through the course, we've seen learners grow in confidence, develop friendships and build really important life skills."

**When Miss May first joined a hip hop chair dance class in the Seddon Centre, Leyton, she didn't know what to expect. "Curiosity brought me here," she said. Two years later, she's one of more than 25 regulars who attend the sessions.**

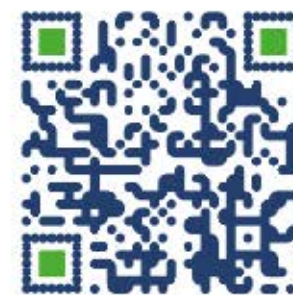

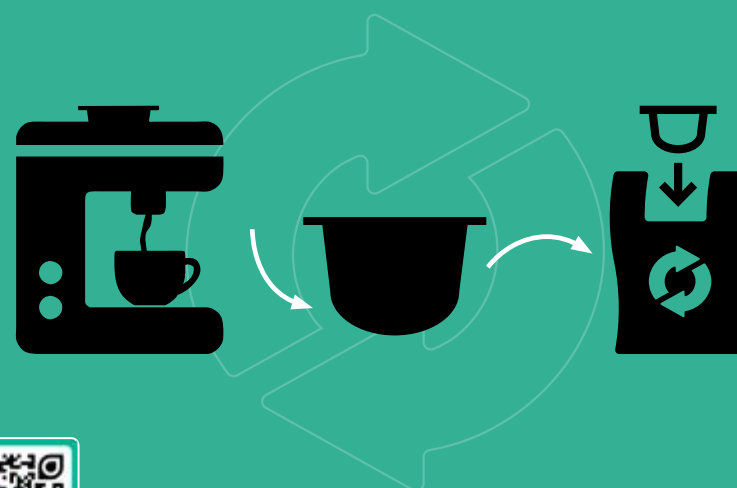

# Doing more for renters and landlords

## How we're improving the private rented sector for everyone

**The cost-of-living crisis, a lack of affordable private rented accommodation, and the impact of the benefit cap on many households have together contributed to a homelessness epidemic across the UK – one that is particularly acute in London.**

Tackling inequality is at the heart of everything we do. To create a more equal borough, we are improving housing security and standards, especially in the private rented sector. With an estimated 28,500 privately rented properties in Waltham Forest - that together account for around 28 per cent of all housing - it's vital that the council proactively addresses these issues.

In November, Cabinet approved a new Private Rented Sector Strategy and Delivery Plan that sets out how we will work together with both tenants to deliver the support, advice, and services residents need and with landlords to drive up standards. Here's what we're doing to...

### Help families living in the private rented sector

We are providing updated guidance on the website for families living in private rented accommodation, including what to do if your private tenancy is ending, negotiating with your landlord, and helping you find a new property to rent.

The new Housing Sustainment Team (HST) is focused on helping referred families at risk of homelessness before they reach a point of crisis. The team provides advice across a wide range of issues including benefits, employment support, and health.

HST has so far helped nearly 90 households sustain their tenancy, preventing them from becoming homeless, including Sally\*, who said: "They helped me negotiate my rent. I really appreciate the help I got." Armina\*, another person helped by the HST, added: "They made it easier to understand the process and helped negotiations with the landlord management company."

### Increase supply and improve standards

With input from teams across the council, we are exploring ways to increase the supply of private rented homes in the borough so that residents can live in Waltham Forest close to families, friends and support networks.

We continue to actively regulate conditions and management practises in the private rented sector, while working with the many responsible landlords in the borough to offer good quality rented homes through our Landlord Forum.

Since 2015 we've overseen the improvement of over 5,000 private rented sector properties. We use the full range of enforcement powers when landlords do not comply with improvement notices.

This shows the importance of compliance in the borough, while protecting renters and improving housing standards. In 2024, we've recorded the most fines in the Mayor of London Rogue Landlord Database.

**In the last month, the Government has approved the council's application to extend its selective licensing scheme for a further five years.**

**The scheme, which covers 20 of the 22 wards in the borough, requires most landlords to register their rental properties and ensure they meet the required standard to ensure tenants are living in safety.**

**The selective licensing scheme extension will come into effect on Thursday 1 May 2025 as soon as the current scheme ends.**

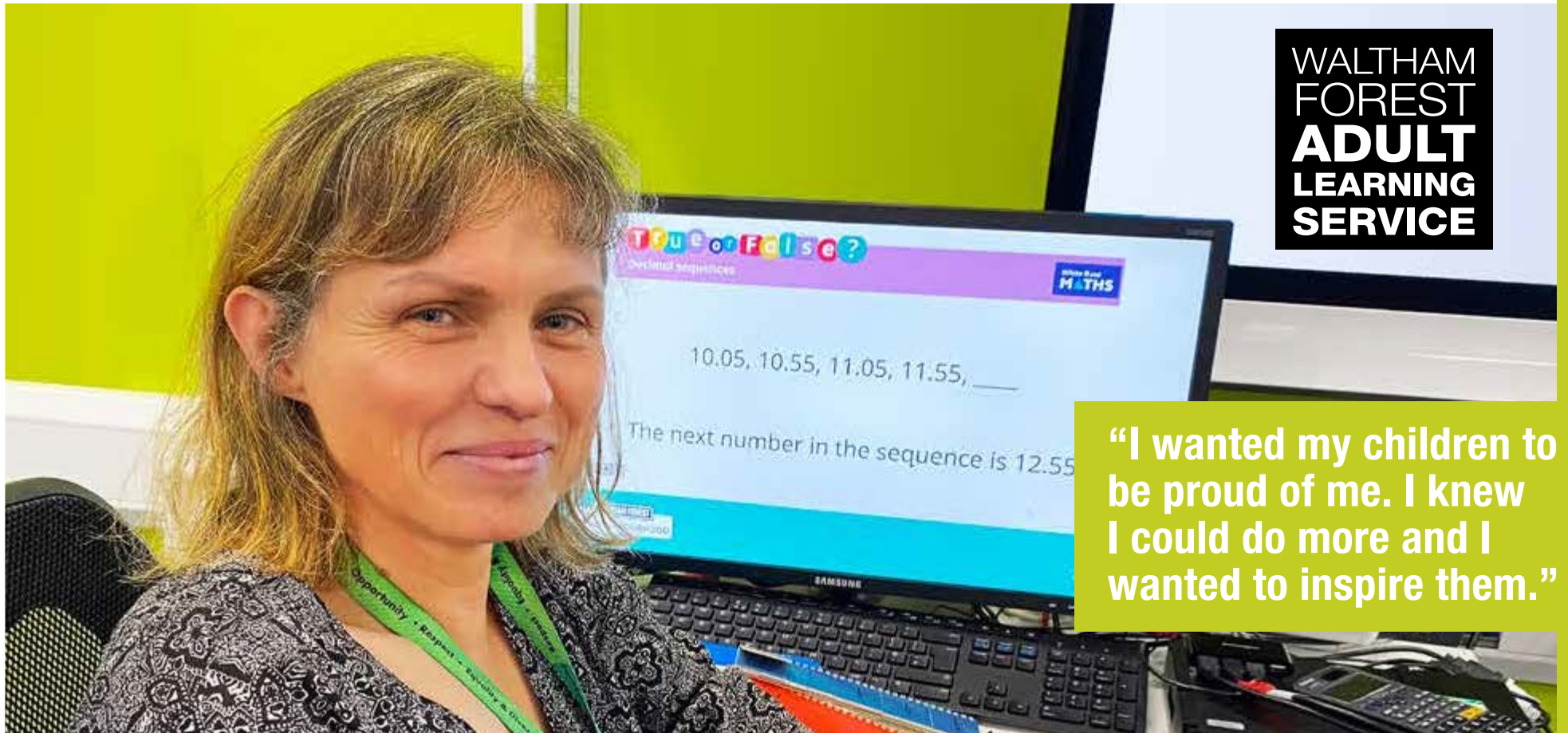

## Jolanta's Learning Journey

### How gaining qualifications opened doors into teaching for learner turned lecturer

**Jolanta arrived in the UK in 2003. As a qualified teacher in her native Poland, she initially set her sights on becoming an accountant but life, as it often does, had other plans. Now, she's a maths lecturer at the very same place she was once a learner.**

Jolanta's journey began at Waltham Forest Adult Learning Services when she started taking accounting and bookkeeping classes. But when she became a single parent, she had to change her plans.

With two young children to take care of, she needed a job that allowed her to work around school holidays. It was then that Jolanta decided that working in education would be the best option for her.

"Despite being a qualified teacher in Poland, I needed GCSE qualifications in English and Maths for me to get a teaching job in the UK."

Determined to get back into the profession she loved, Jolanta returned to studying and enrolled on to a Teaching Assistant course along with Functional skills and then went on to study for GCSE English and maths.

It was a challenging period, balancing study, work and taking care of her children, but Jolanta was driven by a simple yet powerful motivation.

"I wanted my children to be proud of me. I knew I could do more and I wanted to inspire them."

Achieving her qualifications began to open doors for Jolanta and she secured a role as

a teaching assistant and later became a full-time teacher in a secondary school where she worked for over a decade.

When she decided she wanted a new challenge, her former teacher who is still working at Waltham Forest Adult Learning Services, encouraged her to apply for a role at the centre. Jolanta applied for a position teaching maths and hasn't looked back since.

Now in her second year as a lecturer, Jolanta describes the experience as very rewarding. Her classroom is a vibrant mix of learners, ranging from young adults to an 80-year-old learner who proudly calls herself "the grandma" of the class.

Jolanta says: "She brings such warmth and determination to the group - she is proof that learning has no age limit."
